

## **MobileSyrup Bell Samsung Galaxy S21+ 5G Giveaway**

(the “Contest”)

Official Contest Rules (the “Rules”)

The Contest is subject to all federal, provincial, and municipal laws.

Void where prohibited.

**NO PURCHASE NECESSARY**

1. **Contest Sponsors:** The Contest is sponsored by Bell Canada. This Contest will be run in accordance with these Rules, subject to amendment by MobileSyrup. Entrants must comply with these Rules, and, by entering the Contest, will be deemed to have received, understood and accepted the Rules.

2. **Contest Period:** The Contest starts at 19:00 PM (Eastern Daylight Time) on May 17, 2021 and continues until 11:59 PM (Eastern Daylight Time) on June 14, 2021 (the “Contest Period”).

3. **Eligibility:** The Contest is only open to legal residents of Canada (excluding Quebec) who are at least 18 years of age or older. Employees of MobileSyrup and its parent and affiliated companies and subsidiaries, and immediate family members of any such person (regardless of where they live) or those with whom any such persons are domiciled are not eligible to enter the Contest. Entries are limited to individuals only; commercial enterprises and business entities are not eligible to enter the Contest.

4. **How to Enter:** No purchase necessary. To enter the Contest, during the Contest Period, enter to win on MobileSyrup.com.

**ENTRANT IDENTITY:** If the identity of an entrant is disputed, the authorized account holder of the e- mail address submitted at the time of entry will be deemed to be the entrant. The individual assigned to the submitted e-mail address is considered the authorized account holder. A selected entrant may be required to provide proof that he/she is the authorized account holder of the e-mail address associated with the selected entry. All entries must be submitted from a valid e-mail account that may be identified by reverse domain name search. The sole determinant of time for the purposes of receipt of a valid entry in this Contest will be the Contest server machine(s).

5. **Prize:** There is one Prize available to be won: a Samsung Galaxy S21+ 5G (valued at \$1,399.99). Prize must be accepted as awarded and is not substitutable, transferable or convertible to cash.

6. Winner Determination: The eligible winner will be selected on or around June 16, 2021 by a random draw from all eligible entries received during the Contest Period. Odds of winning depend on the number of eligible entries received during the Contest Period.

MobileSyrup will contact the selected entrant(s) using the e-mail address provided to enter the Contest. If a selected entrant does not acknowledge winner notification attempts within forty-eight (48) hours after MobileSyrup's first attempt at contact or, if contacted, does not claim his/her prize, or does not meet all of the Contest conditions outlined in these Rules, the selected entrant will be disqualified and forfeits his/her prize, and another entrant may be selected from among all remaining eligible entries whom MobileSyrup will attempt to contact, and who will be subject to disqualification in the same manner. This process will continue until contact is made with a selected entrant who meets Contests requirements or until there are no more eligible entries, whichever comes first. MobileSyrup is not responsible for failed attempts to notify any selected entrant. Upon prize forfeiture, no compensation will be given.

7. Prize Substitution: Any prize is non-exchangeable, non-transferable, and non-refundable, has no cash-surrender value, and must be accepted as awarded with no substitutions. MobileSyrup reserves the right, in its sole discretion, to substitute and/or modify any prize with (a) prize(s) of equal or greater value for any reason.

Winner Conditions: To be declared a winner, a selected entrant must first: (i) have complied with, be in compliance with, and continue to comply with the Rules; (ii) correctly answer, unaided, a time-limited, mathematical skill-testing question to be administered by Contest Sponsor; and (iii) sign and return a Declaration and Release form within a specified period of time confirming compliance with the Contest Rules and releasing the Releasees (as defined below) from liability in connection with the Contest.

Tampering: All entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means, or do not conform to or satisfy any condition of the Rules may be disqualified by MobileSyrup.
